No use of the Museum will be permitted except that authorised by GTC prior to the booked tour.

Noting a safety limit of 65 people in the Bass and Flinders Maritime Museum and 3 people in the Watch House at any one time, groups may be split up when visiting inside the Museum. This also applies for catering options within the Museum.

GTC reserves the right to cancel attendance or vary without notice, desired tour times and accepts no responsibility for any loss or inconvenience so caused.

The Organisation acknowledges the complete authority of the Tour Guide during the excursion and agrees that all its party shall observe all directions of the Tour Guide during the excursion.

GTC will attempt to tailor the tour to the specific requirements of the group, however, may not be able to do so in all cases. Generally, a tour will be conducted within 1 hour and will introduce the group to the history of the Museum, heritage of the region, the vessels, collections, and lives of original residents in the area.

The Organisation acknowledges that inherently tours of the Museum may involve hazards and that while GTC will undertake all reasonable effort to minimise risk of injury and damage neither GTC nor Officer, servant, volunteer, agent of GTC nor any person employed by GTC shall be liable for any loss or injury to the Organisation or any participant or visitor at the Museum arising from the tour or otherwise during the visit.

No food or drink shall be consumed within the Museum buildings, without prior arrangement.

Payment is due 7 days prior to tour date. Late payments may result in cancellation of your booking.

The group or organiser agrees that this Booking Application including the Terms and Conditions will, if accepted, be a contract with George Town Council. The group or organiser has read, understood, and agrees to this application and the Conditions. These terms and conditions are subject to Commonwealth and State consumer law as relevant.
